Solid Waste Collection

Solid waste is collected on Tuesdays and Fridays. Garbage including bulk items and vegetation is collected on Tuesdays only. Garbage and recycling is collected on Fridays only.

As per Chapter 42 in the Town’s Code of Ordinances, it is unlawful for any person to place any solid waste or any obstruction of any kind upon any street, sidewalk, alley, park, lane or other public grounds of the town or upon any publicly dedicated right-of-way or on the land of another without his consent, except that properly containerized garbage, waste and yard trash may be placed no greater than six feet from the street or road abutting the property generating the subject garbage, waste or yard trash to effectuate proper municipal refuse, garbage and yard trash collection. All waste will be properly containerized and placed in an orderly fashion.

Yard trash shall consist of vegetation only, including, but not limited to grass clippings, bush or tree trimmings, leaves, and weeds, and shall be placed near the street no sooner than 36 hours, or the Sunday prior to the regularly scheduled day of collection (please do not block storm drains). Yard trash (other than normal weekly vegetation) generated by lawn care companies will not be collected by the Town’s trash collector and should be properly removed by the vendor who generated it. Town Manager's Report

Below is Town Manager's Report—August's Commission Meeting:

Town Selection Committee Consideration

In compliance with State CCNA rules, the Commission should consider recommendations for a selection committee to review submissions of our RFQ for an Inlet Cay Island Engineering Drainage Study.



Finance

- Today's earlier workshop meeting was held to help finalize priorities under Commission direction for included capital projects and operational appropriations for the coming "FY18" fiscal year.
- An additional workshop slot is reserved for August 22nd to complete the budget formation process if needed. Public Hearings for formal budget adoption are scheduled September 11th and 21st.
- The FY16 Annual Financial Report presented by Nowlen, Holt & Miner, P.A. was adopted by the Town Commission at the July RTCM meeting. The Auditor stated we should be proud of our good audit with no significant findings. Identified software and procedural items causing tracking and data concerns in FY16/17 were isolated, corrected and procedurally improved for moving forward.
- Bank statements and required source documents are now being fully reconciled directly to the General Ledger. Administration office staff has done a tremendous job working together to improve reporting and accounting procedures to avoid future issues. Proposals for new generation accounting software upgrades are in discussion in the current budget process.

FLC Annual Conference & Legislative Policy Committees

- I will be out of the office on Thursday, Friday and Saturday, August 17-19th attending the 91st Annual Florida League of Cities Conference in Orlando. I represent the Town on the Municipal Administration Policy Committee and FAST (Federal Action Strike Team), and as designated Voting Delegate for Resolutions and other business matters before the League membership.
- We have proposed a slight increase in the Town Commission Travel & Per Diem budget line item to fund an interested Commissioner to attend and participate in this event next year.

General

- To reassure residents, Town of Ocean Ridge Codes prevail within the Town at all times. Significant change to Town Ordinances requires consideration at the Town Commission with their directive to proceed and a process of public meetings and hearings to amend applicable local laws (code). This process assures residents and interested parties plenty of opportunity to weigh in on any proposals presented for Town consideration. Recently, citizens have voiced concerns over media coverage on adjacent cities/county ideas possibly affecting Ocean Ridge (e.g. dogs on beach, Inlet Park, High-speed trains and other general urban expansion impacts).

August's Special & Regular Town Commission Meeting Summaries

 - C. Fund two additional police officers and one additional dispatcher.

12. Directed the Town Attorney to draft a Concept Plan Review Ordinance with a mandatory review process by the Planning & Zoning Commission who would make recommendations to the Zoning Official before a building permit application is submitted.
13. Authorized the town telephone system upgrade in the amount of \$13,388.
14. Authorized the town security camera upgrade in the amount of \$23,076.
15. Approved a one year extension of the legal services agreement between the Town and Torcivia, Donlon, Goddeau & Ansay, PA.
16. Approved the Town Manager's contract as submitted.
17. Adopted on first reading Ordinance No. 624: An Ordinance of the Town of Ocean Ridge, Florida, Amending Its Code of Ordinances by Amending Chapter 66 "Environmental Regulations", Article II, "Floodplain Management", Section 66-21 "Inspections", Section 66-25 "Definitions", Section 66-32 "Manufactured Homes" To Provide Regulations Related to Manufactured Homes; Providing for Codification, Conflicting Ordinances, Severability, and an Effective Date.
18. Building Permit Fee Schedule

Effective 10/1/2008, Revised 10/1/2010, Revised 10/1/16, Revised 5/1/17, Revised 7/1/17

Building Permit Fees are based on the estimated cost of the work rounded up (ex. \$7,200 = \$8,000) **plus** the BIF/DCA Building Surcharge, as follows.

August's Crime Prevention Information From Lieutenant Richard Jones "If You Leave It, Lock It"

Over the last year, the entire State of Florida has seen an increase in vehicle thefts. This increase is larger than ever before with an approximate increase of 12.4 percent. Although the majority of other thefts have decreased in Florida during this time frame, the theft of motor vehicles has been and will continue to be on the rise in Florida.

This is no surprise to me since I have been monitoring this type of criminal increase on a daily basis over the last two years. Many of you are aware of this because our agency has attended a variety of local homeowner's association meetings within our area and have sent out various email blasts regarding these types of crimes in an effort to educate and ultimately protect you.

Although we have seen an increase in these types of crimes within Ocean Ridge, our statistical numbers are much lower than many other communities within Palm Beach County. Even though our numbers are lower than the average, some of our residents have still fallen victim to these types of crimes.

As a result of these increases, the Palm Beach County Police Chiefs Association, in conjunction with the Ocean Ridge Police Department and many other agencies within our area, have agreed that an educational component is necessary to reduce and eliminate these types of crimes from continuing within our communities.

The reason that this educational component is so important is because the large majority of these thefts result when vehicles are left unattended, unlocked and with an ignition key left inside, many times in plain sight or even in the ignition.

In addition to the vehicle being unattended, unlocked and having keys present inside them, many of these thefts have also resulted when valuables were left inside the vehicle in plain view.

With all these factors being known, the best way to reduce these crimes is by preventing it from happening in the first place. So the campaign of, **"IF YOU LEAVE IT, LOCK IT"** is simply that. When you leave your vehicle unattended, lock it. In addition to that, please do not keep or leave any vehicle keys or other valuables inside your vehicle when it is parked or otherwise unattended. Keys and valuables are enticing to the criminal element and, believe it or not, but it takes less than (1) minute for these crimes to occur.

As discussed in previous crime prevention tips, opportunity is what a criminal thrives on. If we take away the opportunity, they will be powerless.

It is obvious this individual, as well as many others, are merely playing on the fact that Ocean Ridge is a safe and nice community and exploiting this to commit their crime of choice.

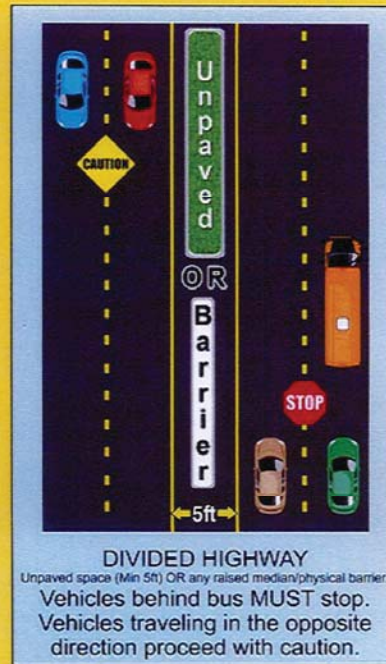
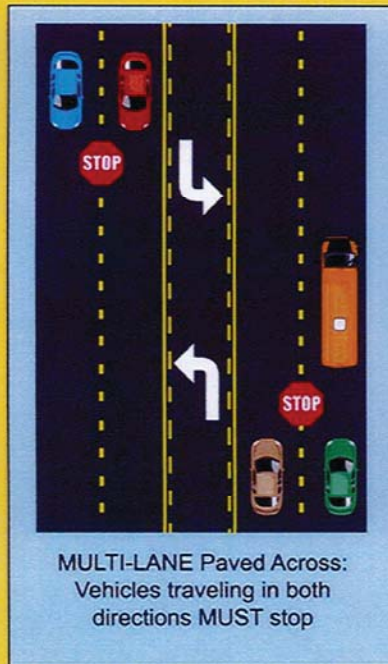
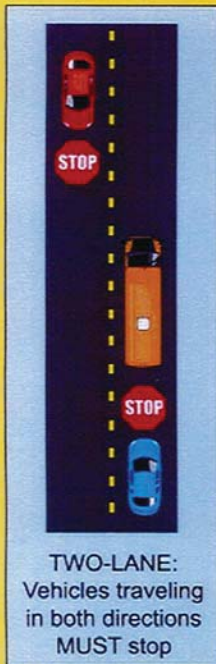
- A one day survey, conducted by the Florida Department of Education in April 2012, showed that more than 21,000 drivers illegally passed a stopped school bus.
- Each illegal pass-by could result in a tragic injury or fatality of a student. The inconvenience of an extra few seconds spent waiting for a stopped bus is insignificant compared to the loss of a child's life.
- Florida Motor Vehicles Laws require that motorists stop upon approaching any school bus which displays its flashing red lights and has its stop signs extended.
- Section 316.172, F.S. states that: Drivers who improperly pass a stopped school bus are subject to a citation, a fine for \$271 and four points on their driver's license.
