Foreclosed Home Registration

A s many of you are aware there has been a problem throughout Florida with foreclosed homes and code enforcement. When the banks foreclose they don't always maintain the property in the way we would prefer. It's difficult many times to find out who we need to contact to keep the properties maintained properly. In an effort to assist in keeping up with this problem, the Town Commission has adopted an Ordinance and has contracted with a firm that specializes in keeping up with the banks. This way we can follow up with code enforcement. The banks will now have to register with the Town on foreclosures and we'll know who to contact. The company works for a portion of the registration fee so it won't adversely affect our budget. We hope this will allow us to keep better control of vacant properties. If you notice any properties in disrepair for this reason you may call Town Hall at 561-732-2635 and we will investigate the issue. - Kenneth Schenck, Town Manager

Beach Restoration

A s many of you are aware we recently had a visit from Hurricane Sandy. We were a lot more fortunate than some of our neighbors but we did have some damage along the ocean. The Town, as well as many of the residents, had severe damage to the dune crossover structures. We have repaired the Town's crossovers. Many of the residents have also repaired their crossovers. Many homeowners had significant erosion to the sand dunes in front of their homes. Fortunately, the Town didn't have any structural damage like Manalapan and others experienced. However, the dunes need to be repaired to protect from future storms. The residents are responsible for repairing the dunes on their private property. The County toured the area with FEMA in hopes of getting a declaration for federal funds to help in the repairs. Unfortunately FEMA has denied the County's request. The denial is being challenged by the County but there's no guarantee they'll change their mind. Even if they do it doesn't mean we'll get any funding for beach repairs. FEMA has said that they don't repair beaches as it's the Corps of Engineer's responsibility. It's unlikely the Corps will get involved at this stage as they have a beach renourishment project planned for Ocean Ridge in December, 2013. In an effort to speed up repairs the State has issued an emergency order thereby allowing the Town to issue permits for crossover and dune repairs without waiting for the State to approve them. However, some repairs may still require State approval. This order expires December 28, 2012. After that time you'll have to contact FDEP for a permit prior to contacting us for a Town permit. So far, and I don't expect any change soon if at all, if a resident has damage to their dune or crossover structures it'll be their responsibility to repair them with the proper Town permit. The State will allow the residents to repair the dunes but we can't do anything to the beach itself. If anyone has any questions please call Town Hall and we'll do what we can to help you.-Kenneth Schenck, Town Manager

Soliciting on the Rise

As a result, these entrepreneurs have been going door-to-door soliciting funds for magazine subscriptions, bogus sports teams (lacrosse, "Irish" soccer, baseball, etc.), and other causes.

The good news is residents have been calling the Police Department to report these visitors and/or suspicious persons, and these calls are greatly appreciated. Our initial response is to meet with & identify the violators, issue them & their company warnings and, as long as they do not have a warrant, send them on their way. Should it become necessary, a stronger message may be needed in the form of a physical arrest.



Again, it is important to note that our investigation has determined that several of these folks have warrants and/or criminal histories, and their companies have had numerous Better Business Bureau complaints filed against them.

Soliciting without a Permit is a Town Code violation. Please continue to call us when you encounter or observe suspicious persons. Your continued support is greatly appreciated.

The End of Another Hurricane Season

ovember 30th marked the end of Hurricane Season and "Sandy" has left her mark along the entire Eastern Seaboard. Although properties in Ocean Ridge were spared much of her wrath, our neighbors to the north (Manalapan to the Tri-State area) witnessed the results of the combination of a powerful storm, high tide and a full moon. The outcome should serve as a reminder that such an event can easily occur here.

The author discusses the fact that the general public is not prepared for such an event and has not been heeding the message from emergency managers. Emphasis is placed on the reality that the majority of folks have no plan to sustain themselves for the first few days following such a disaster. There is an over-reliance on government's responsibility for rapid response; to include assumed, automatic financial aid. Also lacking is a backup plan to communicate with family members should cell phone service become inoperative.

As we gather with our families for this holiday season, we should reflect upon what happened elsewhere and be thankful that we survived another storm season. It might also be a good time to talk about what you would do if faced with such a weather event and what you plan to do to sustain yourself for the first week and then recover from it.

Local Fallen Soldier Remembered

On Saturday, December 1 at 11:30AM family and friends gathered at the southeast corner of the upper-level of Oceanfront Park to dedicate an area and unveil a plaque in memory of PFC. Michael Metcalf; an Army soldier killed in action on April 22, 2012 in Paktia, Afghanistan. Attached are photos of the peaceful, shaded site known as the "Gathering".

"Cowboy Mike" grew up in unincorporated Boynton Beach and attended Park Vista High School with my son. They played hockey together. As a representative of the Town and on behalf of my family, I participated in the event along with approximately 75 others.

After the service, I spoke with Michael's Mom & Dad and, on behalf of everyone in ORPD, expressed our commitment to safeguard this spot.

Please feel free to visit this location to help honor this brave man who gave the ultimate sacrifice to protect his Country.




Ocean Inlet Park Added Security and Parking Restriction

As a result of the documented increased criminal activity and loitering that has been occurring after dark, a meeting with Palm Beach County Parks officials, PBSO, Manalapan PD and Ocean Ridge PD took place on November 29, 2012. Among the actions taken were the housing of a Parks employee at the Inlet and the closure of the main parking lot from dusk to dawn. Both of these responses have already been implemented; the latter on a temporary basis via barricades with

permanent gates being installed soon. This joint effort is an excellent example of the cooperation that exists among these government entities.

These measures allow for the continuation of the required 24/7 access for those fishing or using the marina; while prohibiting others from gathering to create problems.

December's Regular Town Commission Meeting Action Summary

The following list is actions taken at the Dec. 3, 2012 meeting:

- Approved the Regular Town Commission Meeting minutes of Nov. 5, 2012 with a couple of minor revisions that are now clarified in the beginning of the Dec. 3, 2012 minutes
- Approved Resolution No. 2012-17; Designating the Supervisor of Elections and the Town Clerk as the Canvassing Board, to be in Attendance for the Tabulating Equipment Testing and to Canvass Returns of the March 12, 2013 Election Including Absentee Ballots, and Assigning the Supervisor of Elections to Handle the Absentee Ballots
- 3. Approved Resolution No. 2012-18; Approved the Agreement for Vote Processing Equipment Use and Election Services with the Supervisor of Elections
- Approved Resolution No. 2012-19; Renewal of the Multi-Agency Law Enforcement Mutual Aid Agreement for Combined Operational Assistance and Voluntary Cooperation
- 5. Approved Resolution No. 2012-20; Pertaining to Ocean Ridge Vacant Property Registration Fees (Set at \$200)
- 6. Directed staff to research comparable municipalities regarding rental property fees and enforcement of same
- 7. Directed staff to prepare a Letter of Informed Consent for prior Mayor Kenneth Kaleel to represent Ocean Breeze, LLC with their upcoming major site plan submittal pursuant to Florida State Statutes
- 8. Approved the temporary hiring of dispatcher/clerks to be confirmed at the January 7th meeting with email notification prior to that date
- Authorized closing the administrative offices on Monday, Dec. 24, 2012 and Monday, Dec. 31, 2012 to allow for two four day weekends with staff utilizing vacation days
- 10. Authorized Palm Beach County DERM to work 24/7 during Phase 1 to hydraulic dredge the area east and west of the Boynton Inlet commencing in early 2013 and ending prior to April 30, 2013 and also Phase II to consist of mechanical dredging mainly offshore seven days a week from sunup to sundown
- 11. Approved a Retirement Bonus of \$2,200 to Dispatcher Marcia Martin for her 22 years of service but agreed to discuss a possible cap at the January Meeting
- 12. Accepted a donation of \$30,000 from the Support Group (through anonymous donors) for the purchase of a 2013 police vehicle (Ford Explorer) and an amount not to exceed \$5,000 from the Contingency Account to cover the remaining balance
