RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF OCEAN RIDGE, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT TO ALLOW THE TOWN OF OCEAN RIDGE (TOWN) TO COLLECT NON-AD VALOREM ASSESSMENTS PURSUANT TO THE UNIFORM METHOD FOR THE LEVY, COLLECTION AND ENFORCEMENT OF NON-AD VALOREM ASSESSMENTS AS PROVIDED IN SECTION 197.363, FLORIDA STATUTES AND THE TOWN'S LOCAL ADOPTION OF RESOLUTION NO. 2011-03 WITH THE PALM BEACH COUNTY PROPERTY APPRAISERS OFFICE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 197.363, Florida Statutes, allows for local governments to collect non-ad valorem assessments pursuant to the uniform levy, collection and enforcement of non-ad valorem assessments as provided for in section 197.3632, Florida Statutes; and

WHEREAS, the Town is interested in collecting non-ad valorem assessments for Lot Clean-Up and Demolition or Repair of Unsafe Structures when the Town has the work completed and is not reimbursed; and

WHEREAS, the Town on Feb. 7, 2011 adopted Resolution No. 2011-03; Pertaining to Non-Ad Valorem Assessments for Lot Clean-Up and Demolition or Repair of Unsafe Structures; and

WHEREAS, the Palm Beach County Property Appraiser agrees to provide the Town with the information and services outlined in Section 197.3632(2)(b) Florida Statutes; and

WHEREAS, Chapter 92-264, Laws of Florida was enacted to provide that non-ad valorem assessments be set forth in the Notice of Proposed Property Taxes for Palm Beach County.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF OCEAN RIDGE, FLORIDA THAT:

Section 1. The Town of Ocean Ridge hereby authorizes the Mayor to execute the Agreement (attached as Exhibit "A") between the Palm Beach County Property Appraisers Office and the Town.

Section 2. This Resolution shall become effective March 7, 2011.
